- D. \_\_\_\_\_ I am a primary teacher in a home school program, defined by O.C.G.A. 20-2-690(c), with no reasonable alternative arrangements for the home school participants. (*Attach copy of current Declaration of Intent to Utilize a Home School Study Program*) (O.C.G.A. §15-12-1.1(a)(4)).
- E. \_\_\_\_\_ I am the primary unpaid caregiver for a person over the age of six with physical or cognitive limitations. (*Physician's certificate required.*) (O.C.G.A. §15-12-1.1(a)(5)).
